**BUSINESS UPDATE – FURTHER DELAY IN COMPLETION OF SMELTING FACILITY**

*Capitalised terms in this announcement shall have the same meanings as those ascribed to them in the Company’s announcements dated 18 July 2019, 19 September 2019, 7 October 2019, and 1 April 2020 (“**Announcements**”), unless otherwise defined.*

The board of directors (the “**Board**”) of Sen Yue Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to the Announcements regarding the Group’s intention to set up a smelting facility at its current premises at 3 Jalan Pesawat to expand its waste management and processing capabilities and the subsequent delay in the completion of the same due to the COVID-19 outbreak. The Company wishes to update that construction had ceased from 21 April 2020 until further notice due to the COVID-19 outbreak. The Group’s main contractor is awaiting for the approval from the relevant authorities to deploy its workers to resume construction of the smelter post circuit-breaker.

The Board is currently reviewing the smelting project and will update shareholders when there is greater visibility on the timelines for completion of the smelter. The Company does not envisage any material impact on the above to the Group’s earnings per share and net asset value per share for FY2020.

In the meantime, shareholders and potential investors are reminded to exercise caution while dealing in the shares of the Company.
