BUSINESS OPERATIONS UPDATE – NEW CONTRACT AWARD

1. Introduction

The board of Directors (the “**Board**”) of Sen Yue Holdings Limited (the “**Company**”) and together with its subsidiaries, the “**Group**”) wishes to provide further updates following the fulfilment of obligations under the earlier tripartite agreement as mentioned in the Company’s announcements dated 12 December 2021 and 15 February 2023.

2. New Contract Award

SMCI Industrial Pte. Ltd. (“**SMCI**”), the Company’s wholly-owned subsidiary had on 1 March 2023 entered into a new waste supply contract with the same key supplier commencing from the date of agreement to 28 February 2024 (“**New Contract**”). The waste supply under this New Contract involves the recovery and supply of unspent lithium-ion battery materials and is of a monthly recurring nature. Barring any unforeseen circumstances, the New Contract is expected to contribute positively to the Group’s financial performance for the financial year ending 30 September 2023.

Sen Yue Holdings Limited (“**Sen Yue**” or the “**Company**” and together with its subsidiaries, the “**Group**”) is an established metallurgical solutions provider for products used across a diverse range of industries including micro motor, automotive, electrical & electronics, audio visual, screw & fastener, luggage & power tools, bicycles, and general hardware. The main business activities of the Group are classified into three broad business segments: (i) Metal Components, (ii) ED coating, and (iii) Commodities.

The **Metal Components** segment involves the manufacturing and sales of perforated materials including speaker nets and frames, tool and die, and other metal components. It is complemented by the **ED Coating** segment that acts as a secondary and finishing process on metal components, offering coating services such as electrodeposition (“**ED**”) coating, powder coatings, spray-painting, and silk-screening.

The **Commodities** segment is streamlined to providing waste management solutions, treatment, recovery and recycling of industrial waste, electronic waste and lithium-ion batteries waste from the electric vehicle industry.
