On 3 March 2026, Cenvios Holdings Pte. Ltd. (the "Offeror") issued the offer document in relation to its voluntary unconditional general offer ("Offer") for all of the issued and paid-up ordinary shares ("Shares") in the capital of Sen Yue Holdings Limited (the "Company"), other than those already owned, controlled or agreed to be acquired by the Offeror ("Offer Shares"), in accordance with the Singapore Code on Take-overs and Mergers.

As stated in Section 7 of the Offer Document, the Undertaking Shareholders (as defined in the Offer Document), have given irrevocable undertakings ("Irrevocable Undertakings") to the Offeror to, inter alia, (a) tender all the Shares that they hold (directly or indirectly or through a nominee) as at the date of the Irrevocable Undertakings, and any other Shares which they may subsequently acquire (directly or indirectly or through a nominee) after the date of the Irrevocable Undertakings, in acceptance of the Offer; and (b) elect to receive as the consideration for each Offer Share tendered in acceptance of the Offer, one (1) new ordinary share in the capital of the Offeror ("New Offeror Share"), in respect of the relevant Undertaking Shareholder's Shares.

Electroloy has given an Irrevocable Undertaking to the Offeror to, inter alia, elect to receive as the consideration for each Offer Share tendered in acceptance of the Offer, one (1) New Offeror Share, amounting to a total number of 1,750,000,000 New Offeror Shares. Accordingly, immediately after the transaction, Electroloy ceases to be a substantial shareholder of the Company.

The percentage of the total number of voting shares before and after the transaction is calculated based on the total number of 3,238,030,038 Shares.
