Following the Board's review of the report by Foo Kon Tan Advisory Services Pte. Ltd. ("FKT") and taking into account the Notice of Compliance issued by the SGX RegCo on 18 June 2020 (the "NOC"), the Nominating Committee ("NC") has recommended the suspension of Mr Koh Mia Seng's ("Mr Koh") duties as Executive Director of the Company and its subsidiaries with effect from 8 January 2021. Mr Koh has been placed on gardening leave and his duties and responsibilities in the Group has since been assumed by Mr Neo Gim Kiong, the Executive Director and CEO of the Company.

The suspension of Mr Koh's executive duties is an extension of the Board's internal controls previously implemented as disclosed in paragraph 4 of its announcement dated 5 August 2020.

The Board shall release a separate announcement on the findings of the FKT report after it is completed, updates on the efforts undertaken by the Board to address the issues in the NOC and the NC's full assessment of Mr Koh's suitability to remain on the Board of Sen Yue Holdings Limited in due course.

After having interviewed Mr Koh and to the best of its knowledge, the Company's Sponsor, PrimePartners Corporate Finance Pte. Ltd., is satisfied that save as disclosed in this announcement, there are no other material reasons for the redesignation of Mr Koh to Non-Executive Chairman.
